The Institute released two papers in 2015 on the role of aid in helping developing countries improve local governance, strengthen capacity, and raise their own financial resources to achieve the SDGs. These papers were timed with the adoption of the SDGs to stimulate thought among the aid community about what it will take to achieve the new global goals. We continue to develop our thinking on these critical issues. The 2017 Hunger Report on the challenges that fragile and weak states and institutions pose for the goal to end hunger by 2030 will advance our understanding of the issues.

We continue to track USAID's progress in implementing their Nutrition Strategy. We are also continuing to push for completion of the whole-of-government nutrition coordination plan. New USDA guidelines make nutrition a requirement for McGovern-Dole proposals.

The second panel looked at the issue from the perspective of patients and practitioners. It included Sarah Jane Schwarzenberg, American Academy of Pediatrics; John Cook, principal investigator at Children's HealthWatch; Randy Oostra, president of ProMedica and a founder of the Root Cause Coalition; Dawn Pierce, Bread for the World activist, nurse, and former SNAP recipient; and Sylvia Taggart, from the Fruit and Vegetable Prescription Program at Unity Healthcare Clinic in Washington, DC. The event was well attended and garnered strong media and social media interest. During the launch, #hungerreport was trending on Twitter in 1st place for the nation's capital and reached 6th place nationally.

The Institute was also invited to contribute to a Brookings Institution project on Ending Rural Hunger by 2030. In addition to contributing to early thinking and drafts of the report, the Institute helped organize a data visualization event to gather feedback on the interactive features of their website. We also contributed an article on gender and agriculture.

We started producing a new newsletter, Institute Insights, and revived an old one, Fresh Bread. Institute Insights is electronically published monthly and is intended for policy researchers and analysts. Fresh Bread, published electronically when Congress is in session, is a weekly legislative update. Both subscription-based newsletters target
